## PRIVACY AND DATA SECURITY

### YOUR RIGHTS REGARDING PERSONAL DATA

Privacy is one of the fundamental principles within **Kuzeykaa Code of Ethics**. Your personal data is protected under applicable legal regulations, **GDPR**. As a data subject, you have the following rights:

- To learn whether your personal data is being processed
- To request information regarding your processed personal data
- To learn the purposes of processing your personal data and whether such data is used in accordance with those purposes
- To learn the third parties to whom your personal data is transferred
- To request correction of your personal data if it is processed incompletely or inaccurately
- To request the deletion, destruction or anonymization of your personal data where the reasons requiring processing no longer exist
- To request notification of such correction, deletion or destruction to third parties to whom personal data has been transferred
- To object to the occurrence of a result against you by analyzing the processed data exclusively through automated systems
- To request that your personal data be transmitted to you in a structured, commonly used and machine-readable format (right to data portability)
- To withdraw your explicit consent at any time where processing is based on consent
- To seek legal remedies in case you suffer damage due to unlawful processing of your personal data

### PURPOSES AND LEGAL GROUNDS FOR PROCESSING PERSONAL DATA

Kuzeykaa House processes personal data based on the legal grounds set forth under GDPR Article 6, including:

- Your explicit consent
- Being directly related to the establishment or performance of a contract
- Compliance with legal obligations
- Necessity for the establishment, exercise or protection of a legal right
- Legitimate interests pursued by Kuzeykaa House, provided that your fundamental rights and freedoms are not harmed

## PRIVACY AND DATA SECURITY

Within this scope, your personal data is processed for the purposes of:

- enabling you to benefit from our products, services and content,
- providing information about our products and services,
- sharing updates, campaigns and announcements with your consent,
- recording and evaluating feedback, suggestions and complaints,
- improving service quality,
- conducting commercial and strategic planning activities.

Your personal data may be collected verbally, in writing, or electronically through websites, social media channels, mobile applications and similar communication tools.

### TRANSFER OF PERSONAL DATA

Your personal data may be transferred to our business partners, service providers and authorized public institutions and organizations, as well as to real or legal persons located domestically or abroad, in accordance with **GDPR Articles 44–49**. International data transfers are carried out to countries providing adequate protection or by implementing appropriate safeguards (such as standard contractual clauses or explicit consent).

Anonymized tables, graphics, presentations and similar outputs generated from personal data processed for specific purposes may be shared across various communication channels, primarily through the official **@kuzeykaa** and **@kuzeykaahouse** accounts.

### STORAGE AND SECURITY OF PERSONAL DATA

Personal data is retained for the period required by the purposes of processing and as stipulated under applicable legislation. Upon expiration of these periods, personal data is deleted, destroyed or anonymized ex officio or upon request.

Data is securely stored in:

- cloud systems protected by cybersecurity measures,
- website record and log archives,
- physical locked safes owned by Kuzeykaa House.

Access to personal data is strictly limited to the authorized Business Management Team. Identity verification, two-factor authentication, access logs and internal audit mechanisms are actively implemented to prevent unauthorized access.

### PAYMENT SECURITY

Full card details are neither viewed nor stored under any circumstances. In accordance with legal and technical requirements, only the cardholder's name and the last four digits of the card number may be displayed. All payment transactions conducted via [www.kuzeykaa.com](http://www.kuzeykaa.com) are protected with a 256-bit SSL Certificate.
